

## LOCAL LAW # 2-2022

Salary Raises for the Mayor, Deputy Mayor and Board of Trustees

Section 1. Pursuant to the authority granted by Article 2, Section 10, of the Municipal Home Rule Law of the State of New York, the salaries of the Mayor, Deputy Mayor and Trustees of the Village of Dolgeville, effective from June 1, 2022, shall be and hereby are established as follows:

- (a) The annual salary of the Mayor from \$2,700 to \$6,000.
- (b) The annual salary of the Deputy Mayor \$ 3,500.
- (c) The annual salary of each member of the Board of Trustees from \$1,500 to \$3,000.
- Section 2. Any prior local law, rule or resolution inconsistent herewith is hereby repealed.
- Section 3. Pursuant to Section 24 of the Municipal Home Rule Law, this local law shall be subject to permissive referendum by petition. The Village Clerk is hereby directed to post and publish a notice setting for the date of the adoption of the local law, which said notice shall contain an abstract of said local law concisely stating the purpose and effect thereof and shall indicate that such local law is subject to a permissive referendum.
- Section 4. Pursuant to Section 9-902 of the Village Law, this local law shall not take effect until thirty days after its adoption; nor until approved by the affirmative vote of a majority of the qualified electors of the Village of Dolgeville voting on such proposition for its proposal if within thirty days after its adoption there be filed with the Village Clerk a petition signed and acknowledged by electors of the Village in number equal to at least twenty per centum of such electors in said Village, as shown on the register of electors for the previous general Village election, protesting such local law and requesting that it be submitted to the electors of the Village for their approval or disapproval.
