I. PURPOSE

Approved commercial use of the village-owned portion of the parking lot area situated between North Main Street and North Helmer Avenue during the period of May 1 and October 31 of each year has resulted in vehicular traffic flow problems which could be dangerous to the health and safety of the general public. It is the purpose of this local law to remedy these problems in an efficient and fair manner.

II. REQUIREMENTS

Any entity, or individual, desiring to use the village-owned portion of the North Main Street - North Helmer Avenue parking lot area, or any part thereof, for any period of time between May 1 and October 31 shall secure prior formal approval of, and be obligated to all fee and other conditions that may be imposed by, the Board of Trustees. For all approved tent events, the Board of Trustees will provide and, through the Chief of Police, direct the continuous placement of portable traffic control devices including, but not limited to, two (2) Stop signs, four (4) speed bumps, No Parking signs, No Standing signs, five (5) mile per hour speed limit signs, and traffic cones.

III. VIOLATIONS

- A. The violation of this law by any entity, or individual, for not maintaining and/or continually supervising the portable traffic control devices in accordance with the directive of the Chief of Police shall be deemed a civil offense subject to a maximum penalty of \$250.00 per day, or any part of a day, in addition to all statutory costs otherwise recoverable for civil proceedings.
- B. The violation of this law by any individual driving a motor vehicle for failing to stop, speeding, prohibited parking, or ignoring traffic cones shall be deemed a local traffic infraction subject to a maximum fine of \$250.00, in addition to any required surcharge.
- C. The violation of this law by any individual for prohibited standing shall be deemed a local traffic infraction subject to a maximum fine of \$250.00, in addition to any required surcharge.

IV. ENFORCEMENT

This law shall be enforced by any member of the Village of Dolgeville Police Department.

V. JURISDICTION

Any civil proceeding or prosecution commenced under this law shall be in a local court of competent jurisdiction.

VI EFFECTIVE DATE.

This local law shall become effective upon its filing with the Secretary of State.
