Deputy Mayor William Reynolds at Dolgeville Health Center called this Public Hearing of the Dolgeville Village Board of Trustees to order at 6:15 p.m. The Pledge of Allegiance recited.

Public Hearing – Village of Dolgeville Main Street Sewer Rehabilitation and Replacement Project to discuss bond resolution for the financing of this project. Legal Notice read.

Chet Szymanski – Village Engineer and Jason Ballard – B & L came before the Board on the following:

Jason explained the village is applying and qualifies to be placed on the EFC Intended Use Plan at 0% financing. Tonight's public hearing is for information and questions regarding the intended project.

The initial project cost is approximately \$ 7.7 million but the village is targeting the high priority portion which is Main Street @ approximately \$ 3.3 million. The village will apply for grants as they become available to reduce the overall cost of the project.

The target area is South Main Street – North Main Street. Note: the village is hopeful FEMA will cover costs for the flood area of North Main Street.

The cost to consumers will depend on the final project costs and grant funding received.

The proposed area would replace approximately 5,000 linear feet of infrastructure (sewer) and approximately 1600 linear feet of spot repairs that would include lining. The end result is to eliminate storm water to WWTP through laterals and underdrains.

Brian Randall – how about the water lines on Main Street? Some lines need to be replaced and the village is hoping to work with the contractors to replace/repair while the project is open. The village is also hoping to coordinate with NYSDOT to assist and lower costs after the project is complete with the repaying portion.

The vote to proceed lies solely with the Village Board and the bond resolution will be subject to permissive referendum.

A RESOLUTION SUBJECT TO PERMISSIVE REFERNEDUM, THE RECONSTRUCTION AND CONSTRUCTION OF THE SEWER SYSTEM UNDER MAIN STREET AND FOR THE VILLAGE OF DOLGEVILLE, HERKIMER AND FULTON COUNTIES, NY AT THE MAXIMUM ESTIMATED COST OF \$3,300,000 AND AUTHORIZING THE ISSUANCE OF \$3,300,000 SERIAL BONDS OF SAID VILLAGE TO PAY THE COST THEREOF.

WHEREAS, all conditions precedent to the financing of the capital project hereinafter described, including compliance with the provisions of the State Environmental Quality Review Act, have been performed; and

WHEREAS, the capital project hereinafter described has been determined to be a Type II Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed, it has been determined will not result in any significant environment effects; and

WHEREAS, it is now desired to authorize such capital project and its financing; NOW, THEREFORE, BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the Board of Trustees of the Village of Dolgeville, Herkimer and Fulton Counties, New York, as follows:

WHEREAS, it is now desired to authorize such capital project and its financing; NOW, THEREFORE, BE IT RESOLVED, by the affirmative vote of **not less than two-thirds of the total voting strength** of the Board of Trustees of the Village of Dolgeville, Herkimer and Fulton Counties, New York, as follows:

<u>Section 1.</u> The reconstruction and construction of a new sewer system running under Main Street in replacement of the current sewer main and lateral connections, site improvements and

incidental improvements and expenses in connection therewith, is hereby authorized, subject to permissive referendum, at a maximum estimate cost \$3,300,000.

Section 2. it is hereby determined that the plan for the financing of the aforesaid maximum estimated cost is by the issuance of \$3,300,000 of serial bonds of the Village hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law; provided, however that the amount of serial bonds ultimately to be issued shall be reduced by any grants-in-aid received therefor and other loans received.

<u>Section 3.</u> It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is forty years, pursuant to subdivision 4 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

Section 4. The faith and credit of said Village of Dolgeville, Herkimer and Fulton Counties, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all sewer rents of said Village, a rental increase sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to tell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Village Treasurer, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Village Treasurer, consistent with the provisions of the Local Finance Law.

Section 6. The powers and duties of advertising such bonds for sale, conduction of the sale and awarding the bonds, are hereby delegated to the Village Treasurer, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as the Village Treasurer, shall deem best for the interests of said Village, including, but not limited to, the power to sell said bonds to the United States Department of Agriculture and/or the New York State Environmental Facilities Corporation; provided, however, that in the exercise of these delegated powers, the Village Treasurer shall comply fully with the provisions of the Local Finance Law and any order or rule of the State Comptroller

applicable to the sale of municipal bonds. The receipt of the Village Treasurer shall be a full acquittance to the purchaser of such bonds, who shall not be obliged to see the application of the purchase money.

Section 7. All other matters except as provided herein relating to the serial bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, determination to sell to the United States Department of Agriculture and/or the New York State Facilities Corporation, and also the ability to issue serial bonds with substantially level or declining annual debt service, shall be determined by the Village Treasurer, the chief fiscal officer of such Village. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Village Treasurer shall determine consistent with the provisions of the Local Finance Law.

Section 8. The Village Treasurer is hereby further authorized, at their sole discretion, to execute a project finance and/or loan agreement, and any other agreements with the New York State Department of Health and/or the New York State Environmental Facilities Corporation, including amendments thereto, and including any instruments (or amendments thereto) in the effectuation thereof, in order to effect the financing or refinancing of the specific object or purpose described in Section 1 hereof, or a portion thereof, by a bond and/or note issue of said Village in the event of the sale of same to the New York State Environmental Facilities Corporation.

Section 9. The power to issue and sell notes to the New York State Environmental Facilities Corporation pursuant to Section 169.00 of the Local Finance Law is hereby delegated to the Village Treasurer. Such notes shall be of such terms, form and contents as may be prescribed by said Village Treasurer consistent with the provisions of the Local Finance Law.

<u>Section 10.</u> The validity of such bonds and bond anticipation notes may be contested only if:

Such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publications,

or Such obligations are authorized in violation of the provisions of the Constitution.

Section 11. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

<u>Section 12.</u> Upon this resolution taking effect, the same shall be published in full or summary form in the official newspaper of said Village for such purpose, together with a notice of the Village Clerk substantially the form provided in Section 81.00 of the Local Finance Law.

<u>Section 13.</u> Pursuant to the provisions of Section 36.00 of the Local Finance Law, this resolution is adopted subject to the permissive referendum.
