School Capital Project  
Presentation*

Dolgeville Central School Superintendent Joseph Gilfus made a presentation of the upcoming Dolgeville Central School Capital Project for the upcoming vote on March 1, 2022.

The total project cost is \$ 15,800,000 and project highlights include two propositions:

Proposition 1: Maintenance/renovations to aging facilities, upgrades to the bus garage, and a new turf field.

**TAX INCREASE: 0.0 percent**

Building Aid (78%) potentially at 88% pending SED's Bus Garage Aid.

Strong Capital Reserves.

Grant Funds (ESSER & ARP) – toward Capital Reserves, reinstating programs.

Proposition 2: Renovations to the district's athletic complex, including replacing the "Big Blue" building.

**TAX INCREASE: 1.1 percent**

Building Aid (88%).

Local Tax of 1.1% distributed over 2-years.

Local Share of \$ 354,876.00 to be supported by entire school district tax base over a two-year period starting in 2024. An increase of \$ 8 per \$ 50,000 assessment each year or total of \$ 16 over a two-year period in which it ends.

**In order for proposition 2 to pass, voters must first approve proposition 1.**

If voters approve the project, work would begin during the summer of 2023 and conclude around September, 2024.
