- A draft FEMA Engineering Report for the siphon has been delivered to the Village from GHD.
- GHD will be finalizing the North Main Street Engineering Reports within two weeks.
- B&L is still waiting on CCTV inspection footage from Shamrock Sewer Services. If they are able to get them by Friday 8/14, they propose being complete with their report by 8/31.
- Responded to multiple requests for information from FEMA.
- Reviewed the culvert project in the watershed this past month. Recommend that this project is removed from the FEMA program.
- The North Main Street Levee, the Sedimentation Project at the WWTP, and the culverts at the Watershed will be dropped from FEMA.

CHIPS Paving Program

 Assisted Steve in coordination of contractors / timing to implement the paving program for 2020 as discussed at the last Board Meeting.

Water Meters

- Working to obtain pricing for water meters for large water users in the Village.
- Created a detailed list of existing and proposed water meters. Neal is working to fill out the missing details through review of his records and inspections of existing meters.

Beaver Brook Flood Study

 Coordinating the current Beaver Brook modeling and process for the application to FEMA with B&L. Beaver Brook and Fink Creek floodplain revisions will be incorporated into one application to FEMA as the work on Fink Creek progresses.

Energy Performance Contracting / NYPA

EPG for Sanitary Sewer

- Timeframe of report delivery has extended with the lack of CFA's this year. Working towards developing a more thorough report as information changes throughout the year, positioning the Village for a better application in 2021.

NYS Parks Grant

- Continuing to participate in bi-weekly phone calls.

NYSDOT Multi-Modal Grant

- Received direction from NYDOT this past month and recommend that we do not proceed with these projects until the State Comptroller has approved our grant contract with NYSDOT.
