

Village of Dolgeville Engineer's Monthly Update

July 2020

Current Open Projects

Flood Event

- Attended multiple conference calls w/ FEMA and Village representatives this past month.
- Addressing requests for additional information on North Main Street Debris Removal.
- Engineering Reports due from Consultants in the next two weeks for all DLIs.
- The North Main Street Levee and the Sedimentation Project at the WWTP may be dropped by FEMA – A conference call will be scheduled for next week.
- **A proposal from Susan Anacker for North Main Street Levee deed research requires action at the next Board Meeting.**

CHIPS Paving Program

- Currently working with Steve Radomski on the scoping, bidding vs. State Contract, and management of the 2020 CHIPS Program.

Water Meters

- Working to obtain pricing for water meters for large water users in the Village.

Beaver Brook Flood Study

- Stephanie Nurre at Stantec, FEMA's consultant, has reached out to FEMA to find any information on Beaver Brook that may be useful for the Village.
- The 90-day appeal period is currently on pause until the COVID disaster is reduced and municipal functions open back up across the State.
- This stream / floodplain model may be incorporated into the model that B&L will

be producing for Fink Creek as the floodplain for both streams combine as the terrain flattens out near Helmer Ave.

Route 29A Water Line Project

- Reimbursement paperwork / communications continuing.

Working Woodlands / Watershed Carbon Credits

- Discussion on hold until COVID restrictions are lifted.

Energy Performance Contracting / NYPA

- The Village has received the purchase pricing of light fixtures and poles / rental pricing of poles from National Grid after 240 days on 7/16/2020.
- This information will be sent to NYPA for their analysis.

EPG for Sanitary Sewer

- Final comments from the Village are being submitted to GHD next week.
- Need debt service information from Treasurer to finalize the report.
- Anticipate CFA application in 2020.

NYS Parks Grant

- Continuing to participate in bi-weekly phone calls.
- Reviewed and returned comments on the 50% set of drawings from Saratoga.
- Need discussion on a Village donation fund for project expenses.

NYSDOH Disinfection Byproducts

- Delivered a detailed PILOT system letter to NYSDOH prior to the April 30, 2020 deadline per their requirement.
- NYSDOH contacted the Village to acknowledge their acceptance and that they are currently reviewing the proposal.
- No response from NYSDOH has been received to date.

NRCS Grant Assistance

- Based on the needs of the community on North Main Street, the NRCS will not be able to fund the levee project.
- NRCS may still be engaged if work downstream of the WWTP is considered, as recommended in the MMI Report.

WWTP

- Discussions have been on hold this past month with rapid changes in COVID and other priority projects taking effort from needs at the WWTP.
- Will resume discussions for equipment replacement as needed.

NYSDOT Multi-Modal Grant

- Total funding of \$50,000 has been approved and accepted by the Village.
- Funding will be focused on repair of the manhole at the corner of Van Buren Street and Main Street and the main near the corner of Slawson and Main Streets.

DEC Mohawk River Watershed Grants – Round 5

- Paused discussions on this project until awards are officially announced.
