Current Open Projects

DEC Mohawk River Watershed Grants - Round 5

 The Village was officially awarded \$100,000 for this planning project associated with the North Main Street area.

Road Cut Permit

 Assisted the Village with developing a Road Cut Permit Application and Form which was adopted at a Special Meeting earlier this month.

Main Street Sanitary Sewer Emergency Work

- Currently working with the USDA and GHD to start the process of obtaining grant funds from the USDA to assist with the work.
- Projects are listed on the EFC's Intended Use Plan (IUP) for the upcoming year.

Halloween Flood Event (FEMA)

 Draft engineering reports have been received by the Village (and submitted) for all open FEMA projects.

Halloween Flood Event (404 Mitigation Program)

 Responses to the Letters Of Interest (LOI) submitted for the 404 Mitigation Program should be back to the Village by the end of the year. Letters were submitted on September 28th, 2020.

Fulton County Hazard Mitigation Planning

 Currently waiting on responses from the County's Planner regarding some of their additional needs on the report.

North Hudson Area Odor Issues

 Worked with the Amy Mowers to identify some interim strategies to mitigate odor in the area. A proposal for sampling equipment was sent to the Board earlier this month.

Water Meters

 Next step in the process requires Board action to approve the procurement of water meters for set classes of nonresidential water users.

Beaver Brook Flood Study

- Beaver Brook and Fink Creek floodplain revisions will be incorporated into one application to FEMA as the work on Fink Creek progresses.
- A draft letter to FEMA has been prepared outlining technical issues with their floodplain analysis in response to their open comment period.

Route 29A Water Line Project

DASNY reimbursement paperwork / communications continuing.

Energy Performance Contracting / NYPA

- I am following up with NYPA re: their Master Cost Recovery Agreement (MCRA).
- The Village has not ret received or signed the agreement.

NYS Parks Grant

 90% Construction Documents have been delivered to the Village and I have returned comments to Saratoga Associates. The Village has executed the agreement for the project w/ NYS Parks and the project is now awaiting approval from the State.

NYSDOH Disinfection Byproducts

- Delivered a detailed PILOT system letter to NYSDOH prior to the April 30, 2020 deadline per their requirement.
- NYSDOH contacted the Village to acknowledge their acceptance and that they are currently reviewing the proposal.
- No response from NYSDOH has been received to date.
